

# Privacy Policy

This privacy policy sets out how MAKETHEMACT websites protects your privacy online, and how it uses and protects all the personal data - information that you give MAKETHEMACT by signing in the public statement. This policy is effective from 2019/04/17. The MAKETHEMACT websites are built and operated by volunteers of the union non-governmental organization GREEK FORUM OF MIGRANTS, established in Athens – GREECE, for the success of the campaign MAKE THEM ACT.

## What data do we collect?

By signing we collect the following information:

- name
- e-mail address
- country

We also collect:

- Technical information about your use of the website, browser type and version, and operating system.
- Your IP Address through Google Analytics
- Our Cookie Policy describes how we collect information via cookies, pixel tags, and other technologies and how to control your Cookie Settings.

If you are under the age of 16, please ask your parent/guardian for their consent before submitting your personal information to this site. If we have reason to believe that someone is underage and we have collected their personal information without proper consent, we will delete that information in a reasonable period of time.

## How do we collect and store your data?

We collect data and process data when you:

- Sign online
- Use of view our website via your browser's cookies

MAKETHEMACT securely stores your data at servers located in Europe.

## What we do with the information - data we gather

We require this information to forward the MAKETHEMACT mission and message. When you sign, share, we use your personal information to:

- Augment the number of citizens in Greece and other European countries, that agree with this Public Statement and want to act for this campaign.
- Send you information about our work concerning this campaign via email.
- Verify your identity and send you an email to thank you for signing.
- Give you the opportunity to sign campaigns directly from your inbox with one click.

We may use the personal information of all visitors of the site to:

- Answer your queries.
- Analyze how you use the site using tools like Google Analytics.

## **Marketing**

MAKETHEMACT will send you information about the campaign, ONLY:

- If you have agreed to receive information about the PRESS CONFERENCE, when you sign the public statement.

You have the right at any time to stop receiving email from MAKETHEMACT.

## **What are your data protection rights?**

MAKETHEMACT would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – You have the right to request MAKETHEMACT for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification – You have the right to request that MAKETHEMACT correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.
- The right to erasure – You have the right to request that MAKETHEMACT erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that MAKETHEMACT restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to MAKETHEMACT's processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that MAKETHEMACT transfer the data that we have collected to another organization, or directly to you, under certain conditions.
